LNA is required for the NPC Nursing Program. CNA may be converted to an LNA if you have met the minimum hour requirement and background check through AZBN. Anyone with a CNA who is converting to LNA must have 160 hours of work experience as a CNA, which is the practice requirements for LNAs. CNAs are only obligated to work 8 hours in 2 years to renew, but LNAs must have 160 hours in that same time frame.

NAT 101 students and Nursing Applicants must be aware that clinical sites may impose Covid vaccination requirements, which may or may not include waivers for not obtaining the vaccine. Students are obligated to comply with these requirements when they exist in order to attend clinical experiences.

CNA to LNA

Completers may apply upon completion of NAT101 directly to the LNA. If they apply for CNA and then want to convert to LNA, they have to meet the work hours requirement (160) for the LNA. Renewing a CNA license only requires 8 hours worked, but the LNA requirement is much higher. The only way to get around that is to become an LNA from the very start and begin the nursing program before the renewal is due in 2 years (unless they meet required hours for renewal).
