MINUTES - NPC FRIENDS & FAMILY BOARD MEETING

Supporting and promoting lifelong learning through fund raising, advocacy and volunteerism

Monday, June 12, 2023 – 1:00 p.m. – Heritage Museum, Udall Room, Springerville, AZ

- I. **Call to Order –** Board President and Apache County Representative Terry Shove called the meeting to order at 1:35 after lunch and a great tour of the Heritage Museum.
- II. Roll Call and Introductions Present included Pat Ceballos (Vice President Little Colorado Campus); Wendy McVicker (Treasurer Silver Creek Campus); Mary Koury (Painted Desert Campus); Jon Saline (White Mountain Campus) and Betsyann Wilson, Executive Director. Excused include Claude Endfield (Secretary Whiteriver Center), Myrtle Dayzie-Grey (Kayenta Center), and Cara Dukepoo (Hopi Center).
- III. Action Item: Approval of the Minutes of the April 17, 2023 meeting: Wendy made a motion to approve the minutes as presented; Jon Saline seconded the motion. There was no discussion. All voted in favor; no abstentions.
- IV. Action Item: Approval of Treasurer's Report for April and May 2023 – NPC Friends and Family Treasurer Wendy McVicker (Treasurer's report for April 2023 presented on a separate document, since there was no May meeting): Pat made a motion to approve the Treasurer's Report as presented; Mary Koury seconded the motion. Wendy noted the balance in the US account, and also noted that we probably will not move funds into the endowment fund at the end of this fiscal year, due to continuing volatility in the markets. It is a large balance, that will support our 23-24 budget, including the new minigrant initiative. Betsy explained that the two reporting periods for the National Bank of AZ accounts were due to the bank's implementation of a new operating system, and also called attention to the huge increase in the amount of interest on the money market accounts (now 1.0% APR). Wendy noted the gains, then losses in the endowment accounts, underscoring the instability. Terry asked if a motion was needed to not transfer funds. Wendy noted that in past years, she and Betsy had just reported on the intent and amount to transfer, so no vote was needed. Betsy noted we did not transfer funds last year either, since that was the start of the volatility. Betsy is adding donations that are made to the endowed scholarships to the RS account, so the scholarships can continue to be awarded. She will move them from the RS account to the endowed accounts when the economic picture is less uncertain. For now, we can continue to award the scholarships without relying on market returns, which are currently non-existent. Hearing no further discussion, Terry called for a vote on the motion to approve the Treasurer's Report. All voted in favor; no abstentions.

V. Director's Report/Old Business – Betsyann Wilson –

- A. Report on Scholarship Awards FA 23 ATTACHMENT Betsy shared the attachment and noted that she is pleased to be able to analyze the applications using the new, online scholarship application process.
- B. Report on additional NPCFF Scholarships for FA 23: Summit Healthcare Nursing Scholarship; AndyVon Baccalaureate Bound Scholarship; Taking Flight Scholarship in Memory of Dr. Eric B. Henderson; Martin Lucas Memorial Scholarship Betsy noted that the Summit Nursing scholarship will close tomorrow, and she has nine applications to date. The baccalaureate scholarships will close on June 22, and she will open the Martin Lucas Memorial Scholarship after those have been awarded. She noted that all these scholarships have slightly different requirements than the regular NPCFF scholarships, so they fall outside the regular October 1 and March 1 application windows.
- C. Pedal the Petrified 2023 Betsy shared that there are 200 riders registered, as of this past weekend. Due to new state legislation, the college will be selling its multi-passenger vans. Betsy is working on a solution for shuttling one-way riders back to the ride start. She asked Mary Koury if Mary would ask Robbie Koerperich, the Holbrook Superintendent of Schools, if we might use their two short busses. Mary will ask, and said it may depend on whether there is a sporting event scheduled for September 30, in which case the busses will not be available. Betsy said she has a fall-back plan with NPC Director of Facilities, Justin White, to use the college's six minivans.

VI. New Business

- A. Action Item Approval of BDR Richards CPAs, PLC to conduct 2023-2024 audit and taxes– ATTACHMENT – Betsy outlined the estimate and description of services. Mary made a motion to approve contracting with BDR Richards, CPAs, per the attachment; Pat seconded the motion. There was no discussion. All voted in favor; no abstentions.
- B. Action Item Clarification of action taken on October 17, 2022 on allowing "DACA" students to apply for and receive NPCFF scholarships, to include "undocumented" students. Background: Per the Scholarships A-Z group (scholarshipsaz.org – a southern AZ nonprofit that supports undocumented students and youth in pursuit of higher education), as of 2023, there are 281,000 undocumented people in Arizona, In Pima County, for example (where SA-Z operates) there are 32,000+ undocumented people, but only about 2,000 have DACA. About 8,000 are eligible, but the rest are undocumented. To clarify, "DACA" is a legal status that must be granted through an application process. Proposition 300, passed in 2006, denied undocumented people in-state tuition at colleges and universities, but did not prohibit them from being able to access private scholarships. Proposition 308, passed in 2022, provides in-state tuition to undocumented students and other immigrants who otherwise meet the requirements of the college or university they are attending. Betsy recommends clarifying the action taken on October 17: "Mary Koury made a motion that DACA students be allowed to apply for NPCFF scholarships without completing the FAFSA.... Claude Endfield seconded the motion." Suggested motion: Undocumented and international Northland Pioneer College students are allowed to apply for NPCFF scholarships without completing the FAFSA. Mary made a motion to accept the suggested language as presented; Wendy seconded the motion. All voted in favor; no abstentions.
- C. Action Item Action Item Approval of First Quarter Operational Plan for FY 2023-2024 ATTACHMENT Wendy made a motion to approve the plan as presented; Jon seconded the motion. There was no discussion, except that Terry noted she appreciated Betsy's organization. All voted in favor; no abstentions.
- VII. **Next Meeting:** The next meeting will take place on Monday, August 28 at 3:30 p.m. at the White Mountain Campus in Show Low. Betsy will identify a room, and also provide a Zoom or WebEx option.
