- i. HIS 102 Modification to an Existing Course Form Ryan Rademacher
 - 1. Course already received enough votes to move forward in ACRES.

 - i. Lab Readdress IC's Definition Ryan Rademacher
 - In conjunction with this conversation, an e-mail from Wei Ma (01-04-17) was provided and it contained information from a couple of members of the State Quality Matters Consortium regarding online lab. As IC considered the need to readdress their definition of lab, the lengthy discussion included: 1) among other colleges/universities, there does not appear to be a uniform definition of lab; 2) a key factor for several IC members seems to be synchronous instruction with access to the instructor; 3) content should drive delivery mode; 4) safety concerns for certain types of classes; 5) possible solutions include lab component with synchronous lab hours with the instructor or change a class to all lecture; 6) some students only have access to attend online labs at an NPC facility; therefore, should synchronous online labs only be offered when our NPC facilities are open? 7) although load is factored in, IC is

- not in the business of compensation; 8) open labs are not part of the course or the instructor's load; 9) is "practice" homework?
- The definition for laboratory from the Instructions for Course Forms in ACRES was displayed, on the screen, and the IC group worked together to produce a revised definition. (See Instructional Council Group in MyNPC, Document Library for Definition of Laboratory - Instructions for Course Forms in ACRES REVISION 1-13-17.)
- Ken MOVED to approve the Definition of Laboratory Instructions for Course Forms in ACRES REVISION 1-13-17 and give Hallie permission to update the Instructions for Course Forms in ACRES with this revised language; SECOND by Ryan J.
 - a. Motion APPROVED by majority vote.
 - b. There was one NO vote.
