 - i. Josh and Jeremy went over the report and talked about the course that will be created for required orientation for all students (some exclusions). Some specifics about the course are: 1) zero credits; 2) no cost; 3) Academic Advisers will likely teach; 4) one in-person session and the remainder will be online; 5) if student does not take the course or complete it, their registration will have a hold for the following semester.

- V. Old Business Not Related to Curriculum
 - a. Distance Education Classrooms, Naming Conventions Ryan Rademacher [Cindy Hildebrand and Mindy Neff were also available to offer their expertise]
 - There was a great deal of discussion regarding the naming conventions in the distance education classrooms; and, some specific suggestions for changes to the Course Delivery Methods document (approved by IC 10-09-15) include: 1) change four character codes to two characters SA = Stand Along, CC =

Connected Course, MC = Multi-Course; 2) add HY for Hybrid; 3) add OL for Online; 4) add AL for Alternative Learning in case it is ever needed; 5) under CC section, delete last sentence that says "An academic adviser can answer questions prior to registering for these classes." 6) under the Alternative Learning section, add the following sentence (right after if says "toward an NPC degree program.") "Students seeking evaluation of prior military training do not pay tuition charges for their assessed credits."

- ii. These changes will allow better utilization of the Building and Room Number fields. Additional course information can be entered into the Schedule Comments field.
- iii. <u>Task</u>: Ryan R. will make the needed changes to the Course Delivery Methods document (approved by IC 10-09-15) and bring it back to IC.

- a. Guided Pathways/Jobs for the Future Process Mark Vest
 - i. AZ community college presidents are moving forward with some type of agreement with Jobs for the Future.
 - ii. There is an upcoming presentation at Central Arizona College as part of the kickoff for statewide guided pathways. NPC will have representatives attend.
- b. Placement Mark Vest
 - i. We will move to Accuplacer Next Generation, as our current version is not available after 12-30-18. Accuplacer is not providing concordance tables; there is a statewide effort to pull a group of faculty together to develop cut scores; and, Ryan J. and Brian Burson will be involved. Changes need to be decided by mid-March.
 - Some high schools are not in favor of using high school G.P.A. for placement and instead want NPC to placement test all their students who attend NPC.
 Discussion followed, including potential drawbacks and possible solutions.
