To apply for a DPS Level 1 Fingerprint Clearance Card

Go to: Http://www.azdps.gov/services/public/fingerprint

In the middle of the page, on the left, right below ABOUT US (grey box) click on grey bar: Fingerprint Clearance Card Applications, Requests, and Status Checks. Click it, then the blue Fingerprint Clearance Card, click continue. Click apply for a card, and continue. Right below blue LOGIN box is it's easy to create one, create account. Account Type: Individual. After account created it needs to be verified, check email and click confirmation link. It will take you directly back to site to login. Then it will ask to send a one-time passcode to your email, enter this number and login. Click fingerprint clearance card, continue, blue box Apply for Card, then click continue. Answer each question. When you get to Reason (s) for Applying go to the bottom where is states **Additional Sponsors,** 4th one from the bottom. Click Health and Sciences Student and Clinical Assistant ARS 15-1881. Next fill out your application in its entirety, click continue. Next Signature, please read. Electronic is quickest, if you select paper they will send you a hard copy of your fingerprint card from DPS. Then **Review** your application make sure it is correct, double check! Click Continue, it is \$65.00 click submit and pay. You will need a debit or credit card. If you picked electronic you will get an email with a register ID #, in the email it will also give you directions to get your prints electronically and where to go in Navajo County.
