Thank you for your interest in the Northland Pioneer College Associate of Surgical Technology Degree Program.

Only complete applications received in the Allied Health Department Office by November 13th, 2026, 4:00 pm will be considered for admission. Late applications will be considered on a space available basis if they meet the admission criteria but will not be accepted before applications are submitted on time. Please include this checklist as the first page of your application packet. If you are not already an NPC student, please enroll and obtain a Student ID # **prior to** submitting the application. You may enroll by going to your nearest campus or center or on-line at: <https://www.npc.edu/Application>.

****NOTE: Applicants must be aware that clinical sites may impose COVID and Influenza vaccinations requirements, which may or may not include declinations for not obtaining the vaccines. Students are obligated to comply with these requirements when they exist in order to attend clinical experiences.**

Submit the following items:

- ◊ Completed, signed and notarized application.
- ◊ Signed Notice of No Guarantee of Certification.
- ◊ Transfer students must submit official transcripts (in original sealed envelope) from original institution(s) for all prerequisite and co-requisite courses to the Records and Registration (R&R) office at PO Box 610 Holbrook, AZ 86025. Transcripts can also be sent electronically to Records and Registration (evaluation@npc.edu). Meet with an Advisor once you have submitted your transcripts. To guarantee that your transcripts are evaluated and sent to the Allied Health -SGT Department before the application deadline we strongly recommend that your transcripts are received in the R&R office by November 1st, 2026. Please plan accordingly. If an official transcript has previously been received and posted to your NPC account, you do not need to order it again unless you have taken additional coursework.
- ◊ You are required to meet with an NPC Academic Adviser and have a **Degree Audit** printed to include with your application. If you are transferring credits you should meet with an Academic Adviser after the courses have been posted to your NPC transcript but before the deadline date. Transferred courses will appear on your transcript in MyNPC.
- ◊ Math placement score at minimum of: Next Gen ACCUPLACER 263 Arithmetic/Numeric; or ACT 17 or MAT101/HES101 MAT109 or higher completed within three years.
- ◊ A one page typed double spaced "Personal Statement" must be submitted with the application. The "personal statement" should address why you wish to attend the SGT program, what you have done to meet your goals, and what you bring to the Surgical Technology Program. Please describe any experience you have as a healthcare provider, including the location, job description, number of years and responsibilities in that role.
- ◊ Include a copy of your current Arizona DPS Level 1 Fingerprint Clearance Card (front and back). Apply at: <http://www.azdps.gov/services/public/fingerprint> as a health science student. Plan as the process requires 6-8 weeks or more barring any problems. (If your application is still being processed, enclose a copy of your receipt). A copy of the clearance card must be received before registering for any SGT course. If you need instructions on how to obtain a fingerprint card, contact an Academic Advisor.
- ◊ All students must provide current proof of valid Healthcare Provider Cardiopulmonary Resuscitation (CPR) and First Aid (FA) certification by January 19th, 2027, and keep current throughout the program. No online courses are accepted for healthcare programs. See an academic advisor to sign up for EMT104 for the scheduled CPR/FA courses offered. Please provide CPR/FA cards with application if student already has current certifications.
- ◊ You will meet with the Surgical Tech instructor after a complete application is submitted for an interview.

You are responsible for making sure that all of the required documents are received in the Allied Health office *on time*. If *all items* are not received on time your entire application will be considered late.
