#### 1. Arizona POST Updates – Chad Kreuger

- 1.1 Transition from POPAT to Pat;
  - Arizona POST is replacing the POPAT physical assessment with the new Physical Assessment Test (PAT).
  - PAT will involve an obstacle course including stairs, running/jogging, hurdles, window entry, and a four-foot fence.
  - The test will be administered three times, similar to POPAT.
  - Academy Staff will need time to acquire and set up the required equipment.

#### 1.2 New "Patrol Tactics: Course

 Arizona POST is consolidating several classes into a new Patrol Tactics course.

- The new course encompasses: Crimes in Progress, Building Clearing and High-Risk Stops.
- Only Patrol Tactics—certified specialty instructors may teach the material.
- Additional instructors are needed; several candidates are already progressing through the certification process.

#### 2. Intergovernmental Agreements (IGAs) – Chad Kreuger

Had questions and concerns on:

- Not all signed IGAs have been returned.
- Board members are asked to send signed copies as soon as possible so they can be forwarded to the Board for review.

### 3. Upcoming Academy Class – Chad Kreuger

- The next academy class start date was originally January 12, but has been moved to January 6 due to college scheduling constraints.
- The session will begin on a Tuesday because the college is closed on January 5.
- Agencies that have registered recruits should receive information shortly (if not already).
- Agencies planning to send recruits are strongly encouraged to reserve seats now so the academy can plan appropriately.

#### 4. Academy Length and Federal Compliance Issues – Chad Kreuger

Concerns were raised based on federal financial-aid and college-calendar regulations regarding the current 21-week academy model. Three options were reviewed:

#### Option 1 – Reduce to 20 Weeks (Cut ~40 Hours)

- Would require removal of non-mandatory classes such as, Taser, Below 100, TIMS, and Intox-related training.
- Not favored due to training value and agency impact.

#### Option 2 – Maintain 21 Weeks but Align Exactly with College Calendar

- Would require academy start/end dates to match the college schedule with no flexibility.
- Example issue: A 21-week block ending on December 25, when the college is closed.
- Considered impractical and unworkable.

#### Option 3 – Move to a Non-Credit Academy Model (Preferred)

- Academy remains 21 weeks with no loss of training hours.
  - Recruits initially receive no college credits, but upon graduation may submit a form, and receive 36 college credits toward the Administration of Justice degree.
- Similar to how other Arizona academies operate.
- Credit processing fee (~\$45) would likely be covered by the college.
- Board members expressed support; consensus favored maintaining current training hours and shifting to a non-credit model.

Decision: Proceed with maintaining the current academy length under a noncredit structure, pending final administrative steps.

## 5. Administration of Justice (AJS) Program – Chad Kreuger

- NPC is working to expand enrollment in the AJS degree program.
- Courses are affordable, transferable, and include diverse pathways (law enforcement, probation, paralegal, emergency medical refresher, etc.).
- Agencies that offer tuition assistance are encouraged to inform employees of the opportunity.
- Interested individuals can contact the presenter for guidance.

#### 6. Vehicle Needs – Chad Kreuger

- The academy is in critical need of patrol vehicles for training.
- Both patrol-ready and non-patrol vehicles (for scenario training) are useful.
- Agencies with vehicles available for transfer are strongly encouraged to contact the academy.
- Eight new vehicles are currently on order, pending political/administrative delays.

#### 7. Current Academy Class Update – Chad Kreuger

- Current class is in week 17 of 21.
- Recent accomplishments include completions of Module 2 scenarios and Modules 2 written exam (all passed).
- Recent training was the Active Assailant course.
- Upcoming training is High-Risk Stops (last time taught under the old structure).
- Final Exam will be held on December 10.
- Graduation will be held on December 12, at 3:00 pm at the NPC Performing Arts Center, Snowflake.
- An invitation will be sent; agencies are encouraged to attend.

Reminder: Agencies intending to enroll recruits in the next class should notify the academy immediately.

Adjournment: Chad thanked everyone for attending.
