#### **WHO QUALIFIES?**

- All current high school students who are residents of Navajo and Apache counties. Students must meet the placement requirements for the courses they plan to take. Courses are available for students beginning their freshman year of high school! See an Early College Advisor for details.

#### **HIGH SCHOOL VS. COLLEGE**

- Early College is a unique opportunity for high school students to elevate their college/university and career preparation through various certificate and degree pathways! A successful Early College student is expected to:
  - Recognize that NPC Early College Programs consists of college-level courses that are **more** challenging **than** traditional high school courses
  - Prioritize NPC Early College courses in addition to high school courses, sports, etc. by setting aside ample time **outside** of class to complete college coursework
  - Adhere to the NPC Academic Calendar and Student Code of Conduct in addition to the high school Academic Calendar and high school Student Code of Conduct

- **Please seek help EARLY from an NPC Instructor first, an Early College Advisor, and/or a High School Counselor/Career Tech, when needed!** NPC Early College students are *strongly* encouraged to take full advantage of all student services provided at no cost to students.

- The Family Educational Records and Privacy Act (FERPA) ensures that student records are kept confidential. Despite the age of the student, disclosure (including to parents) of all Early College student records must be explicitly granted by the enrolled student through a Release of Student Information (ROI) form. If this form is completed and on file at NPC for an Early College student, the college can also share general information, but nothing specific to a student's records. ### ○ **For Students and/or Families:**

- **Please read your syllabus often!**  
**This is required in ALL NPC classes!**
- For every 1 credit hour in which you enroll, plan to spend 2-3 hours outside of class to study per week!
- Please visit your NPC instructor's office hours (virtually or in-person) and seek tutoring when needed! When in doubt, ask for help! Note: **Please remember, an NPC instructor is your first point of contact for all class related issues!** If your issues are not resolved by an NPC instructor, you may then contact the appropriate NPC Department Chairperson. If your issues are not resolved by the NPC Department Chairperson, please contact the appropriate Academic Dean.
- **Regular attendance and active participation are required for students in ALL NPC classes including online (Ex. TALON)!** Students should see their NPC instructor for details or if they have questions.
- If you are a student taking an in-person NPC class, you are expected to stay in class for the entire time unless otherwise advised by your NPC Instructor. This includes staying on the college premise and not leaving for any reason. No exceptions! Students should see their NPC instructor for details or if they have any questions.
- **Regular attendance and active participation in Early College Pre-session courses are required for students each semester!**

- These pre-session courses include covering topics such as learning how to:
- Access and use the college's main internal site for students and employees to access college resources (e.g. transcript requests, library, bookstore, etc.) called **MyNPC**.
- Access and use the college's learning management system (LMS) called **Moodle** to access all course content and information in addition to other key topics necessary for student success.
  - **Note:** Utilizing these college resources and systems are **required** for students in addition to what is utilized in their high schools.
