- I. **Call to Order –** President Terry Shove called the meeting to order 3:38 p.m.

- III. Action Item: Approval of the Minutes of the November 27, 2023 meeting: David Wright made a motion to approve the minutes, as presented; Pat Ceballos seconded the motion. No discussion, all voted in favor, no abstentions.

- V. Director's Report/Old Business Betsyann Wilson -
 - A. Report on Scholarship Activity Spring scholarship analytical report; Report on first awardee for the WMCOA In the Service of Health; three more FA 23 CME awardees; First cohort of BAS-ECE awardees - Attachment - Betsy called attention to the scholarship analytical report that was displayed on the room screen. She pointed out the slight increase in the number of applications, compared to the number that were qualified, noting that she thought it was encouraging that more students were following the application instructions. Betsy called for questions. She also shared that Melanie Francis, a student in the Little Colorado Campus Medical Assistant (MDA) program is the inaugural winner of the White Mountain Commissioned Officers Association (WMCOA) In the Service of Health scholarship. Melanie travels each week from her home between Chinle and Pinon to Winslow to attend classes. Three additional Claude Millet Endfield Early Childhood Education scholarships were awarded for fall to Branson Parent of Show Low, Delta DeClay of Whiteriver, and Molly McGavock of Lakeside. This brings the total number of awardees for the 23-24 academic year to six. Four inaugural Bachelor of Applied Science in Early Childhood Education scholarships, each in the amount of \$1,000.00, were awarded to Larissa Barela of Winslow, Celena Ambrose of Holbrook, Debbie Burbank of Hopi, and Amandalynn Truax of Whiteriver.
 - B. Change in Eligibility Criteria for US Military Veteran's Scholarship: Celia Iguado, NPC's Veteran's Certifying Official, suggested that this scholarship be available to ALL Veterans and their dependents, not just those who are NOT using the GI Bill. Each semester, Celia sends direct emails to all registered Veteran students, letting them know of the availability of the scholarship. Even so, we receive very few applications for the scholarship. Betsy has changed the application criteria to open the scholarship to ALL Veterans and their dependents; the change will apply for the Fall 2024 application cycle. Thank you to Celia for this suggestion!
 - C. Update on NPCFF How-To Manual, a.k.a. Hit-by-a-Bus File Betsy reminded the group that she annually updates a document that contains the annual calendar for NPCFF activities, as well as account information, to be used in the event of an unforeseen emergency. Her direct supervisor, Dr. Chato Hazelbaker, and Rebecca Hunt, who now works with Technology and Advancement Services on the implementation of the college's new Enterprise Resource Planning (ERP) system, know how to access the files. They would also contact the NPCFF board president and treasurer in the event of such an emergency, to assure key functions of NPCFF would continue to be carried out.
 - D. New Del E Webb Foundation Grant Proposal for NAT-IET Program (LOI Attachment) Betsy explained that a similar grant proposal was awarded by DEWF in 2020, just prior to the start of the pandemic. Because of the pandemic, the NPC nursing dean was unable to hire qualified faculty. The funds were returned to DEWF. The foundation strongly encouraged NPCFF to apply for such a project again, when the pandemic restrictions had passed. College and Career Prep (CCP) faculty, Jesse Reeck, spearheaded the request that Betsy reapply, and Tabitha Stickel, Associate Dean of CCP,

as well as Ruth Zimmerman, NPC Dean of Nursing, concurred with Jesse's request. Dean Zimmerman helped to revise the budget, and Jesse worked closely with Betsy to update a letter of interest, followed by the complete application. The letter of interest was well-received by DEWF, and NPCFF was invited to submit the full proposal. The full proposal has been reviewed and approved by Reeck, Stickel, and Zimmerman, and will be submitted this week. As with the 2018 DEWF grant, which funded a similar project for the Whiteriver Construction Technology program, Betsy will manage the funds and reporting. Funds, which will be used exclusively to support students in the IET-NAT program, will be disbursed to students in the same manner as NPCFF restricted scholarships, going through the business and financial aid offices.

E. Report on Second Quarter Operational Plan outcomes – Attachment Betsy called for questions. There were no questions.

VI. New Business

- A. Request to Approve Third Quarter Operational Plan (Action Item attachment) Betsy called for questions. There were no questions. She pointed out the two key activities for the upcoming quarter include preparations for AZ Gives Day and Pedal the Petrified 2024. David Wright made a motion to approve the Third Quarter Operational Plan; Pate Ceballos seconded the motion. There was no discussion. All voted in favor; no abstentions.
- B. Request to Approve Mini-Grant Proposal Tonya Thacker, Project Director, NPC Title III ARMSS (A Relational Model for Student Success) grant (attachment, with **Q&A from Director Thacker) -** Betsy introduced Tonya and shared the proposal to the screen. Tonya reminded the group of the five key strategies of the grant project, described in the proposal. Strategy 5 is the Native American Student Success Initiative, directed at building better relationships with students at the remote Native American centers in Kayenta, Hopi and Whiteriver, and bringing the community to the centers. This is where Tonya's request for mini-grant funds will be directed. Tonya recapped that the intention of the mini-grant proposal is to provide students with an incentive to participate in her brownbag-lunch information series that will be offered in-person at the three Native American centers. The incentive for students to complete the seven-session series is the three-credit tuition waiver, for which funds are requested in the mini-grant proposal. Claude Endfield asked if participants would have to present a tribal ID number, or if it was OK if students who reside on the reservations, (including those who are denied from tribal rules due to blood quantum) to participate. Tonya noted she had not thought of the blood quantum issue, but she feels that as long a student attends a tribal center as their home center, they could participate. Tonya does not want to make the program restrictive. As long as the student attends all the seminars in person, they will be eligible for the waiver. Cara asked: As a former NPC center manager (Hopi Center), will there be supports provided to the staff to implement the strategies Tonya mentioned? Cara also asked if there was any support for transportation and child care. She asked if the classes could be offered online, if the students don't have transportation and/or childcare. Finally, Cara asked if Tonya was working with the librarians to offer financial literacy classes. Cara also asked if the classes would be offered at the campuses to Native American students. Tonya answered each

question: For the classes offered at the centers, Tonya herself is traveling to the centers to teach them. She has already been working closely with center staff and has great working relationships with them. Tonya will be presenting each topic, so no training of center staff will be needed. As for the online option, it will not be offered at this time. Part of the reason for this is that students are more engaged if they are face-to-face. Tonya understands the need for an online option, and she will be using surveys to ascertain student responses at the beginning and end of each class. If students indicate a strong desire for an online option, Tonya will look into it. Tonya stressed that activities she is planning to achieve goals related to the Title III grant are established by the grant itself. These include increasing the number of Native American students who come to the centers, with the idea of engaging them in the student experience and advancing a sense of belonging. Also, the Title III grant is specific to the tribal centers, not the campuses. The grant does benefit all students at NPC, but Strategy 5 is specific to the Native American centers. Cara noted that she just wanted to remind everyone that transportation and childcare are always issues. NPC is smart about leveraging technology, so she would like that technology to be used where possible. David Wright asked how long the workshops are. Tonya replied that they are going to be held twice per month from 11:00-1:00, so the Title III grant can pay for the lunch portion. Tonya noted she will be working with the NPC Financial Aid Office to make two of the sessions related to financial literacy. Claude asked for a reminder of what funds are set aside in the NPCFF budget for the mini-grants. Betsy responded that the board approved \$22,500.00 in the 23-24 budget for the purpose of awarding mini-grants. Claude made a motion to approve the mini-grant proposal for the full amount requested (\$6,750.00): Wendy seconded the motion. There was no further discussion, prior to the vote. All voted in favor; no abstentions. Claude asked if there would be reports letting the NPCFF board know how the students are doing as the project is happening. Claude asked if maybe midway through, Tonya could let us know how students are doing. Betsy responded that she can convey the progress of the classes, per Tonya, as well as the number of students who receive the waiver. Tonya noted there will be a web page established for each center, so this part of the Title III project will be highlighted on the new web pages.

C. Request for approval of proposal for use of scholarship funds transferred from Northland Pioneer College to NPC Friends and Family (November 27, 2023 action item) Mariner Scholarship funds = \$11,164.02; Real Estate Scholarship funds = \$12,414.13: The Mariner Scholarship will be presented as a new NPCFF scholarship for Fall 2024, using the same eligibility criteria as prescribed when the scholarship was established. NPC will be offering a new Bachelor of Applied Science in Management in Fall 2024. As with the BAS in Early Childhood Education, students who wish to enter the program will not be eligible to receive financial aid through the FAFSA until the program is accredited, which can take one year. Because NPC no longer has a real estate program, NPCFF executive director Betsyann Wilson proposes designating the funds from the Real Estate Scholarship as a restricted scholarship of \$1,000.00 per student, per semester, for students in the new BAM degree program. As with the BAS-ECE scholarship, a new and more rigorous application will be developed, and applicants may submit their applications via email directly to Betsyann Wilson, as with other special scholarships, such as the Martin Lucas Memorial Scholarship. Claude Endfield made a motion to approve the use of the

- scholarship funds as described; Pat Ceballos seconded the motion. There was no discussion. All voted in favor; no abstentions.
